TO THE HONORABLE JUDGE OF SAID COURT OF CRIMINAL APPEALS: COMES NOW, BARTON RAY GAINES, the PETITIONER, and files this motion for an extension of NINTY (90) DAYS, in which to file a Petition for Discretionary Review.

I.

The Petitioner was convicted in the 213th District Court of Tarrant County, Texas of the offense of Aggravated Robbery with a deadly weapon in Cause Number's <u>CR-0836985A</u> and <u>CR0836979A</u>, styled State of Texas vs. Barton Ray Gaines, On December 12, 2002 and received two thirty five (35) year sentences to run concurrent with an \$10,000 fine.
