APPELLANT'S DOCKETING STATEMENT

Per Rule 32.1 of the Texas Rules of Appellate Procedure (TRAP), Appellant Barton R. GAINES files this his docketing statement in the appeal at hand.

(a)(2) Appellant is not represented by an attorney. His name is Barton R. GAINES, His address is 2661 FM 2054, Tennessee Colony, Texas, 75884. Because he is in prison, he doesn't have a telephone number or fax number, but he can be reached by telephone per TDCJ Board Policy, BP 3.81, Sec. VII., which is 903-928-2211.

(b) The date the notice of appeal was filed in the trial court, or mailed per the mail-box rule, was on 2-21-20. That was the date Appellant mailed it to the clerk.

(c) The trial court's name and county is the County Criminal Court, Number Eight, Tarrant County, Texas. The name of the judge is Charles L. Vanover, but Magistrate Charles P. Reynolds actually tried the case. Reynolds signed the order appealed from on 2-5-20, or Vanover did the same on 2-6-20.

(d) The date of filing of appellant's motion for new trial was on 2-13-20.

(e) The only other party to the trial court's judgment is Sharen Wilson, the Tarrant County Criminal District Attorney (TCCDA).

(f) The general nature of the case is a writ of habeas corpus in accordance with Article 11.09 of the Texas Code of Criminal Procedure.

(g) The appeal's submission should be given priority, but it is not an accelerated one under Rule 28 or another rule or statute.

(h) Appellant will not request a reporter's record because none was made.

(j) The appellant does not intend to seek temporary or ancillary relief while the appeal is pending.

(k)(1) On 2-21-20 appellant filed an affidavit of indigence.

(2) To-date there has been no contest of appellant's indigency.

(l) Appellant will not file a supersedeas bond.
